

# SX-GATE Software-Lizenzvertrag

Nachfolgend sind die Vertragsbedingungen für die Benutzung von "SX-GATE" durch den Endverbraucher aufgeführt. Durch Inbetriebnahme des Gerätes erklären Sie sich mit diesen Vertragsbestimmungen einverstanden. Bitte lesen Sie daher den nachfolgenden Text vollständig und aufmerksam durch. Soweit Sie mit den Vertragsbestimmungen nicht einverstanden sind, dürfen Sie das Gerät NICHT IN BETRIEB nehmen!

Nach aktueller deutscher Rechtsprechung können in der Computerbranche auch englischsprachige Lizenzbedingungen wirksam vereinbart werden.

## § 1 Leistungsumfang/Zusicherungen

Die Zusicherung von Eigenschaften bedarf einer ausdrücklichen schriftlichen Vereinbarung. Dies gilt auch für Preisangaben oder Angaben zur Freigabe von Ergänzungen und Erweiterungen. In Prospekten, Dokumentationen oder ähnlichen Schriften enthaltene Angaben stellen nur Beschreibungen dar und enthalten keine Zusicherung von Eigenschaften.

## § 2 Softwarelizenz

1. Durch die hiermit gewährte Softwarelizenz erhält der Endkunde ein persönliches, nicht ausschließliches und nicht übertragbares Recht zur Nutzung der lizenzierten Software. Zur Gewährung von Unterlizenzen ist der Endkunde nicht berechtigt. Ist der Endkunde eine juristische Person, gewährt XnetSolutions KG das Recht, innerhalb der Organisation eine Person zu bestimmen, die das alleinige Recht hat, die Software zu nutzen, so wie in diesem Lizenzvertrag festgelegt.
2. Falls es sich um eine benutzerabhängige Softwarelizenz handelt, muss der Endkunde, der die Software durch mehrere Mitarbeiter einsetzen möchte, eine der Benutzerzahl entsprechende Lizenz (Programm) erwerben. Zu keinem Zeitpunkt darf die Anzahl der Benutzer die lizenzierte Anzahl übersteigen.
3. XnetSolutions KG erklärt sich mit einer Weiterveräußerung und Vermietung oder Schenkung der Software nur dann einverstanden, wenn sich der erwerbende Dritte mit der Weitergeltung der Vertragsbedingungen auch ihm gegenüber einverstanden erklärt. Im Falle einer Weitergabe muss der Kunde dem neuen Anwender alle vorhandenen Kopien übergeben. In Folge der Weitergabe in Form von Veräußerung oder Schenkung erlischt das Recht des alten Anwenders zur Programmnutzung. Im Fall der Weitergabe durch Miete, Leasing oder Leihe steht dem überlassenden Anwender kein Recht zur Nutzung zu. Der Kunde ist in den genannten Fällen verpflichtet, XnetSolutions KG unverzüglich den Namen und die vollständige Anschrift des neuen Anwenders mitzuteilen.
4. Die Überlassung technischer Programmdokumentationen, insbesondere des Quellcodes wird durch Überlassung dieser Lizenz nicht geschuldet. Ausgenommen davon ist die Einsichtnahme oder Herausgabe der Komponenten, die den Bedingungen des § 4 unterliegen.
5. Die Software als Ganzes darf nur insoweit kopiert oder vervielfältigt werden, als dies für den Betrieb auf der lizenzierten Anlage und zur Archivierungs- und Sicherungszwecken notwendig ist. Ausgenommen sind hier die § 4

unterliegenden Komponenten. Weitere Kopien, auch Kopien des Handbuches oder Teile davon, darf der Endkunde nicht anfertigen. Weitere Exemplare des Handbuches sind über Ihren Fachhändler zu erwerben. Überlassene Unterlagen, einschließlich angefertigter Duplikate und Kopien, sind vom Endkunden nach Nutzungsende unaufgefordert zu vernichten.

6. Der Endkunde wird sämtliche Informationen über die Software vertraulich behandeln. Er verpflichtet sich, die überlassene Software und Dokumentation vor Kenntnisnahme oder Gebrauch durch Dritte zu schützen. Der Endkunde verpflichtet sich, keine Teile der Software oder wesentliche Verfahren oder Ideen hieraus, mittelbar oder unmittelbar zur Erstellung eigener Software zu verwenden. Für Komponenten die § 4 unterliegen gelten unter Umständen abweichende Bedingungen.

7. Alle Rechte, insbesondere Urheberrechte an der überlassenen Software sowie der überlassenen Dokumentation, stehen ausschließlich XnetSolutions KG zu. Ausgenommen davon sind die Komponenten die den Bedingungen des § 4 unterliegen.

8. Die Softwarelizenz wird auf unbestimmte Zeit gewährt und kann von XnetSolutions KG nur aus wichtigem Grund gekündigt werden. Ein wichtiger Grund liegt insbesondere vor, wenn der Kunde seinen vertraglichen Verpflichtungen nicht nachkommt.

### § 3 Gewährleistung für Softwareprodukte

1. XnetSolutions KG weist darauf hin, dass es nach dem momentanen Stand der Technik nicht möglich ist, Software so zu erstellen, dass sie in allen Anwendungen und Kombinationen, insbesondere auch in Verbindung mit verschiedenen Hardware-Komponenten, fehlerfrei arbeitet.

2. XnetSolutions KG leistet Gewähr dafür, dass die lizenzierten Softwareprodukte die Funktionen und Leistungsmerkmale erfüllen, die in den zum Zeitpunkt der Lizenzerteilung gültigen Benutzerhandbüchern für die betreffenden Produkte enthalten sind und nicht mit Fehlern behaftet sind, die den Wert oder die Tauglichkeit zu dem nach dem Vertrag vorausgesetzten Gebrauch aufheben oder wesentlich mindern. Die technischen Daten, Spezifikationen und Leistungs-Beschreibungen in der Produktbeschreibung stellen keine Zusicherung dar, es sei denn, sie sind ausdrücklich als solche bestätigt worden.

3. Für den Fall, dass bestimmte Funktionen oder Leistungsmerkmale der Software-Produktbeschreibung nicht erfüllt werden und dies innerhalb der Gewährleistungsfristen vom Kunden schriftlich gerügt wird, erfolgt nach Wahl von XnetSolutions KG die Rückerstattung des bezahlten Preises oder Nachbesserung, die auch darin bestehen kann, dass dem Kunden eine neue Programmversion zur Verfügung gestellt wird.

4. Bleiben wiederholte Nachbesserungsversuche erfolglos und mindert der Fehler den Wert oder die Tauglichkeit zu dem nach dem Vertrag vorausgesetzten Gebrauch wesentlich, hat der Kunde ein Recht auf Rückgängigmachung des Vertrages oder ein Recht auf Herabsetzung der Vergütung.

5. Der Gewährleistungsanspruch entfällt hinsichtlich solcher Programme oder Programmteile, die vom Kunden selbst geändert oder erweitert werden, es sei denn, der Kunde weist XnetSolutions KG nach, dass solche Änderungen oder Erweiterungen für den Mangel nicht ursächlich sind. Der Gewährleistungs-

anspruch entfällt ferner für Fehler, Störungen oder Schäden, die auf unsachgemäße Bedienung, Fehler der Hardware, der Betriebssysteme oder sonstige, außerhalb des Verantwortungsbereichs von XnetSolutions KG liegende Vorgänge zurückzuführen sind, oder wenn der Kunde XnetSolutions KG die Möglichkeit verweigert, die Ursache des angemeldeten Fehlers zu untersuchen.

6. Es gilt die gesetzliche Gewährleistungsfrist.

7. Weitergehende Gewährleistungsansprüche, sind ausschließlich über den Abschluss von Software-Pflegeverträgen gegeben.

8. Ergibt eine Überprüfung oder Mängelbeseitigung, dass kein Gewährleistungsfall vorliegt oder eine unvollständige Rücksendung des Produkts erfolgte, werden die hierdurch verursachten Kosten mit aktuell gültigen Stundensätzen berechnet.

#### § 4 Integration der Lizenzbedingungen von Open Source Software

Teile des Produktes unterliegen individuellen weiteren Lizenzbedingungen. Diese werden in den Kapiteln ab Seite 5 dieses Lizenzvertrages aufgeführt und sind, für die unter den jeweiligen Bedingungen publizierte Software, ausdrücklicher Bestandteil dieser Lizenzbedingungen.

Im Speziellen ist dabei folgendes herauszuheben:

Sofern dies durch die entsprechende Lizenz geschuldet ist, bietet XnetSolutions KG an, jedem Dritten eine vollständige maschinenlesbare Kopie des Quelltextes dieser Komponente zur Verfügung zu stellen - zu nicht höheren Kosten als denen, die durch den physikalischen Kopiervorgang anfallen -, wobei der Quelltext auf einem für den Datenaustausch üblichen Medium weitergegeben wird. Diese Zusage gilt für drei Jahre, sofern dem keine Abweichende Bestimmung entgegensteht.

Jegliche Haftung von Seiten der Autoren und Copyright-Inhaber der betroffenen Komponenten ist in der Regel ausgeschlossen. Es gelten die Bestimmungen der jeweiligen Lizenz.

#### § 5 Mängelrüge

Der Endkunde hat das gelieferte Produkt unverzüglich auf Mängel und Qualität hin zu überprüfen. Beanstandungen des Produkts sind innerhalb von 8 Tagen seit Empfang des Produkts schriftlich gegenüber XnetSolutions KG geltend zu machen.

#### § 6 Haftung

1. Zum Ersatz von Schäden, gleich aus welchem Rechtsgrund, einschließlich Verzug, Unmöglichkeit, Verschulden bei Vertragsschluss, positiver Vertrags-Verletzung, schuldhafter Verletzung von Nachbesserungspflichten und unerlaubter Handlung, ist XnetSolutions KG nur verpflichtet, wenn

- der Schaden auf Vorsatz oder grobe Fahrlässigkeit von XnetSolutions KG oder auf das Fehlen einer zugesicherten Eigenschaft zurückzuführen ist, oder
- XnetSolutions KG eine wesentliche Vertragspflicht fahrlässig verletzt und dadurch der Vertragszweck gefährdet ist.

2. Die Haftung ist in jedem Fall auf den Ersatz typischer, vorhersehbarer Schäden begrenzt, bei Kaufleuten im Sinne des Handelsgesetzbuches auf maximal den Kaufpreis beschränkt. Bei Datenverlust beim Endkunden oder sonstigen berechtigten Anwendern ist die Haftung auf den Wiederherstellungsaufwand bei Vorhandensein von Sicherungskopien beschränkt.

3. Die Haftung für mittelbare Schäden, Mangelfolgeschäden oder entgangenen Gewinn ist, soweit gesetzlich zulässig, ausgeschlossen.

4. Eine Gewährleistung oder Haftung greift nur, wenn der Fehler reproduzierbar ist.

Alle Rechte unterliegen dem Recht der Bundesrepublik Deutschland. Die Hager einheitlichen Kaufgesetze werden ausgeschlossen. Nachträgliche Ergänzungen oder Änderungen von Verträgen bedürfen der Schriftform. Sollte eine der Bestimmungen dieses Vertrages unwirksam sein oder werden, so berührt dies die Wirksamkeit der übrigen Bestimmungen nicht.

## 2 Die Artistic Lizenz

### Preamble

Therefore, we have designed this version of the GPL to prohibit the practice for those products. If such problems arise substantially in other domains, we stand ready to extend this provision to those domains in future versions of the GPL, as needed to protect the freedom of users.

Finally, every program is threatened constantly by software patents. States should not allow patents to restrict development and use of software on general-purpose computers, but in those that do, we wish to avoid the special danger that patents applied to a free program could make it effectively proprietary. To prevent this, the GPL assures that patents cannot be used to render the program non-free.

The precise terms and conditions for copying, distribution and modification follow.

## TERMS AND CONDITIONS

### 0. Definitions.

This License refers to version 3 of the GNU General Public License.

Copyright also means copyright-like laws that apply to other kinds of works, such as semiconductor masks.

The Program refers to any copyrightable work licensed under this License. Each licensee is addressed as you. Licensees and recipients may be individuals or organizations.

17. Interpretation of Sections 15 and 16.

If the disclaimer of warranty and limitation of liability provided above cannot be given local legal effect according to their terms, reviewing courts shall apply local law that most closely approximates an absolute waiver of all civil liability in connection with the Program, unless a warranty or assumption of liability accompanies a copy of the Program in return for a fee.

### Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it. For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. You must make sure that they, too, receive or can get the source code. If you link other code with the library, you must provide complete object files to the recipients, so that they can relink them with the library after making changes to the library and recompiling it. And you must show them these terms so they know their rights.

We protect your rights with a two-step method: (1) we copyright the library, and (2) we offer you this license, which gives you legal permission to copy, distribute and/or modify the library.

To protect each distributor, we want to make it very clear that there is no warranty for the free library. Also, if the library is modified by someone else and passed on, the recipients should know that what they have is not the original version, so that the original author's reputation will not be affected by problems that might be introduced by others.

Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder. Therefore, we insist that any patent license obtained for a version of the library must be consistent with the full freedom of use specified in this license.

Most GNU software, including some libraries, is covered by the ordinary GNU General Public License. This license, the GNU Lesser General Public License, applies to certain designated libraries, and is quite different from the ordinary General Public License. We use this license for certain libraries in order to permit linking those libraries into non-free programs.

The ordinary General Public License therefore permits such linking only if the entire combination fits its criteria of freedom. We call this license the "Lesser" General Public License because it does Less to protect the user's freedom than the ordinary General Public License. It also provides other free software developers Less of an advantage over competing non-free programs. These disadvantages are the reason we use the ordinary General Public License for many libraries. However, the Lesser license provides advantages in certain special circumstances.

For example, on rare occasions, there may be a special need to encourage the widest possible use of a certain library, so that it becomes a de-facto standard. To achieve this, non-free programs must be allowed to use the library. A more frequent case is that a free library does the same job as widely used non-free libraries. In this case, there is little to gain by limiting the free library to free software only, so we use the Lesser General Public License.

In other cases, permission to use a particular library in non-free programs enables a greater number of people to use a large body of free software. For example, permission to use the GNU C Library in non-free programs enables many more people to use the whole GNU operating system, as well as its variant, the GNU/Linux operating system.

Although the Lesser General Public License is Less protective of the users' freedom, it does ensure that the user of a program that is linked with the Library has the freedom and the wherewithal to run that program using a modified version of the Library.

The precise terms and conditions for copying, distribution and modification follow. Pay close attention to the difference between a "work based on the library" and a "work that uses the library". The former contains code derived from the library, whereas the latter must be combined with the library in order to run.

**GNU LESSER GENERAL PUBLIC LICENSE TERMS AND CONDITIONS FOR COPYING, DISTRIBUTION AND MODIFICATION**

0. This License Agreement applies to any software library or other program which contains a notice placed by the copyright holder or other authorized party saying it may be distributed under the terms of this Lesser General Public License (also called "this License"). Each licensee is addressed as "you".

A "library" means a collection of software functions and/or data prepared so as to be conveniently linked with application programs (which use some of those functions and data) to form executables.

The "Library", below, refers to any such software library or work which has been distributed under these terms. A "work based on the Library" means either the Library or any derivative work under copyright law: that is to say, a work containing the Library or a portion of it, either verbatim or with modifications and/or translated straightforwardly into another language. (Hereinafter, translation is included without limitation in the term "modification".)

"Source code" for a work means the preferred form of the work for making modifications to it.
